

## PLACES #9 | IDM LOCATION TOUR Terms and Conditions

Please read the general terms and specific requirements carefully.

### Who can apply?

1. PLACES #9 | Location Tour is open to professional producers, directors, screenwriters and production managers. We particularly encourage professionals from Italy and German-speaking countries to apply. **However, this is not an eligibility criterion. Thus applicants from other countries are more than welcome.** Should the number of participants exceed the planned number of guests, applicants who are already working on a concrete project will be favoured. If the participant is unable to participate in the tour, he or she may ask a colleague to participate in their stead. This decision is, however, subject to the consent of IDM Südtirol.
2. Applicants are asked to submit their CV and filmography. Those presenting a project may also attach its synopsis.
3. Applicants must be at least 18 years old at the time of application.
4. Applications deadline is on **September, 3<sup>rd</sup> 2020.**

### How much does it cost?

5. The participation fee for the location tour costs EUR 100.00 + VAT per person. The fee includes a full boarded accommodation, as well as all transportation costs that may arise during the location tour in South Tyrol. The participants have to bear any travel expenses and personal expenses.
6. The participation fee must be paid via bank transfer. Further information will be provided once the list of participants has been defined. The participation fee shall only be reimbursed in the event of IDM Südtirol being forced to cancel the location tour due to force majeure.

### Covid-19 Health Emergency - Prevention and Management

7. IDM Südtirol hereby mandates that all its employees are required to observe general preventive measures against Covid-19 until the end of the declared emergency by the State of Italy. The preventive measures protocol of IDM Südtirol is available upon request. Everyone participating in the location tour is required to take all necessary measures to prevent and manage the spread of the virus during the Covid-19 emergency.

### Data privacy

8. IDM Südtirol warrants that documents and information submitted will be made available only to people directly involved in the selection process.
9. The applicants agree that, in the event of their participation in the location tour, their profiles and pictures may be published on IDM Südtirol website and that they shall make available to IDM Südtirol appropriate materials for PR purposes and press articles.
10. The Personal Data you will provide shall be used exclusively for the purpose of the registration for and execution of an event and may possibly and solely for this purpose be transferred to third parties. Providing these details is a prerequisite for participation. By registering, the registering person declares their consent to the processing of their Personal Data pursuant to Regulation (EU) 2016/679. The processing of data may be carried out with or without the aid of electronic means, in any case in an automated manner, and will include all the operations necessary for processing provided for in Art. 4(2) Regulation (EU) 2016/679. In any case, the data will be processed in compliance with all the security measures that guarantee their security and confidentiality. Failure to grant consent may result in rendering participation in the event in question impossible. The event will be photographed and may be documented in audio-visual form. The photographs taken may subsequently be published on the IDM Südtirol website and in social media channels as well as in print and online trade publications. Any publication shall be exclusively in the context of and in connection with the event. Please note that the photographs will be available worldwide when published on the internet. By registering for an event, you grant your consent for photographs to be taken and used pursuant to the applicable Art Copyright Act. The declaration of consent shall apply from the date of registration until the moment you leave the event. You may withdraw this declaration of consent at any time with future effect. Any such withdrawal shall result in the removal of published photographs from IDM Südtirol's online presence and no other photographs being published. Deletion of the photographs from the online presence after receipt of your withdrawal of consent may take a few workdays. For published group pictures, the subsequent withdrawal of an individual person's consent shall not automatically result in the picture having to be removed.

The General Data Protection Regulation grants the data subject the possibility to exercise certain rights under Chapter 3 of Regulation (EU) 2016/679, in particular the right of access to personal data and the right to rectification or erasure.
