- To submit for approval any material referring to the support received from IDM Film Fund & Commission.
- To inform IDM Film Fund & Commission of any press conferences, interviews, or any other promotional event, and to inform IDM Film Fund & Commission of the collaboration and services received.
- To hand over free of charge still photos for institutional purposes, or to allow a delegated camera operator from IDM Film Fund & Commission to take still photos and "backstage" shots.

The applicant

declares

- that he/she understands that selection for the scouting program does not in any way guarantee direct access of the project to the provincial audiovisual fund managed by IDM Film Fund & Commission.
- that he/she agrees that even in the event of non-selection for the scouting service the application documents will remain the property of IDM Alto Adige.
- that all the information contained in the application for the scouting service, as well as the attached documentation, is correct.

Privacy protection

Any such withdrawal will result in the removal of published photographs from IDM Südtirol's online presence and no other photographs being published. Deletion of the photographs from the online presence after receipt of your withdrawal of consent may take a few workdays. For published group pictures, the subsequent withdrawal of an individual person's consent will not automatically result in the picture having to be removed.
